## **Overview**

Thank you for being an online viewer of this videoconference. In order to view this conference you will need to have the following on your computer system:

- a 28k modem or higher (for audio/video) or high speed Internet access via a T1 line or LAN
- a set of speakers and a sound card
- [Microsoft Media Player](#) or [Realplayer](#) software

### **Reception Issues**

This cybercast will be sent out in 3 streams: 28k, 56k and 100k. The greater bandwidth you have, the better the picture will be. Your computer will stream the video at the highest speed it is capable of. If you are viewing at a lower bandwidth, you may notice that the picture stops or “buffers”. This is normal and the video should begin playing on its own in a short time.
